

### Community Conversations

BIPOC-focused resource program designed to name and navigate systemic racism in child care finance

Promotes growth/sustainability of BIPOC-owned child care businesses by building business capacity and skills related to securing and managing capital

Cohort comprised of 8 sessions over 4 months

- Sessions facilitated by FCF staff or contracted facilitator representative of community
- Guest Experts representative of the community and working in the subject area invited to present



### Community Conversations

Participants must complete financial action plan and financial analysis of their business

Topics determined with input from community and include:

- Assessing your strengths as a business owner
- Credit and wealth-building
- Procuring & managing a child care facility
- Entrepreneurship & tax issues
- Historical & racial trauma
- Managing revenue from public sources

Cohorts to date: African-American, Somali, Hmong and Latinx





### Community Conversations: Access to Capital



### Forgivable Loans

- Eligible to apply upon completion of cohort and cohort assignments
- Licensed child care provider in good standing with Minnesota Department of Human Services
- \$5,000 for family provider, \$20,000 for child care center
- 3-year term, with one-third forgiven after each year upon completion of 8 hours of technical assistance
- Forgiven term can be reported to credit agencies as successfully closed loan
- 3% interest on any outstanding amount at default (less prior forgiven amount)

### **Lessons Learned**

- Participants hesitant to engage in underwriting process
- Many participants have declined opportunity
- Take time to build trust between FCF and community


